#### Let's talk about it!

Maybe you know someone like Lucille (not her real name), whose granddaughter misused her conservatorship and bilked her grandma out of \$500,000. Older adults in Montana are continuing to fall victim to financial scams. As many as one out of every five seniors is a victim of financial exploitation, most often perpetrated by family members. While older adults like Lucille are among the fastest growing group of victims of financial abuse, currently our state has no legal process to provide restitution for a situation like hers.

Flathead County Agency on Aging, the Montana Area Agencies on Aging Association (M4A) and Montana SMP are doing something about it with a campaign to educate the public and talk about this growing problem. "Face It—Senior Financial Fraud Happens!" is designed to get people talking about how we can help prevent financial exploitation of more Montana seniors.

You'll learn what some seniors around the country are doing by watching a free

documentary film entitled "Fleeced." This will be followed by a local expert panel discussing how seniors can protect themselves. Older adults, their families, and caregivers are invited to attend the event Wednesday, June 15<sup>th</sup>, 2:00-4:00 pm at Flathead Valley Community College, Arts and Technology Building, 777 Grandview Drive in Kalispell.

Our panel will include experts from the Office of the Montana State Auditor-CSI, Kalispell Police Detective Division, Adult Protection Services, and Senior Medicare Patrol. Be sure to bring your questions for them! Call 758-2471 to find out more details.


