

NOTICE OF PASSAGE OF RESOLUTION OF INTENTION BIGFORK ZONING DISTRICT

The Board of Commissioners of Flathead County, Montana, hereby gives notice, pursuant to Section 76-2-205(5), M.C.A., that it passed a Resolution of Intention (Resolution No. 956DM) on July 12, 2018 to change the zoning designation in a portion of the Bigfork Zoning District from CCC-1 (Commercial Country Corner-Class 1) to B-2 (General Business).

The boundaries of the area proposed to be amended from CCC-1 to B-2 are described as:

A tract of land in the Northeast Quarter of the Northeast Quarter (NE1/4NE1/4) of Section 20, Township 27 North, Range 19 West, P.M.M., Flathead County, Montana. Tract 1 of Certificate of Survey No. 11319.

The regulations defining the CCC-1 and B-2 zones are contained in the Flathead County Zoning Regulations, on file for public inspection at the Office of the Board of Commissioners, Courthouse, 800 South Main, Room 302, Kalispell, Montana, at the Flathead County Planning and Zoning Office, 40 11th Street West, Kalispell, Montana, and on the Flathead County Planning and Zoning Office's website at: [http://flathead.mt.gov/planning\\_zoning/downloads.php](http://flathead.mt.gov/planning_zoning/downloads.php)

Documents related to the proposed zone change are also on file for public inspection at the Flathead County Commissioners' Office and the Planning and Zoning Office.

For thirty (30) days after the first publication of this notice the Board of Commissioners will receive written protests to the change proposed for a portion of the Bigfork Zoning District from persons owning real property within Flathead County whose names appear on the last completed assessment roll of Flathead County and who either are registered voters in Flathead County or execute and acknowledge their protests before a notary public.

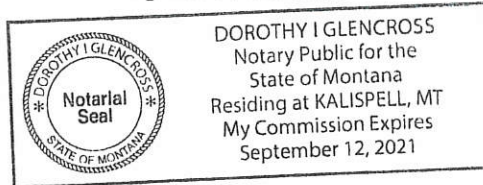
