

INSTRUCTIONS FOR FILING A PETITION FOR RELIEF FROM REGISTRATION
PURSUANT TO MCA 46-23-506

To petition the Court to be released from the registration requirement pursuant to Montana Code Annotated § 46-23-506 you will need to complete and file two forms --they are a Petition and an Order.

The costs is \$120.00 per petition filed, payable to the Clerk of District Court at the time you file your Petition. If you are unable to pay the filing fee, you may submit a Fee Waiver Affidavit and Order – also found on the Clerk’s website at http://flathead.mt.gov/clerk_of_court/links.php. This Affidavit and proposed order must be filed at the same time you file your Petition and Order.

- 1) Fill in all of the blanks in both the Petition and the Order – note that the Certificate of Service in the Petition requires you to send a copy of the Petition to the County Attorney in the County where you are filing the Petition.
- 2) Make two copies of the completed original Petition – one for you to retain and one to be mailed or delivered to the County Attorney.
- 3) The Court will allow a statutory timeframe for the County Attorney to respond. If there is no objection the Court may grant the petition and a copy of the order will be emailed to you. If the County Attorney objects to the petition the Court will likely set a hearing. A copy of the Notice of Hearing will be emailed to you.
