Russell reported a co-applicant agreement has been approved by the Board of Health and should be signed before long. He then spoke about increasing vaccination fees from \$15 to \$20; reported pertussis is still in the valley with 127 cases reported over the past 12 months, and explained communicable disease activity is reported to the Board of Health and State of Montana on a monthly basis. In other business, he spoke about environmental health activity where typically, 130 inspections are made per month; reported 15 septic permits were issued in the month of December and he reviewed financial statistics. Russell noted the Animal Shelter is looking at building a 20 X 28 addition off the front east side of the shelter in order to adjust their intake flow of animals.
