#### Dear Flathead County:

Thank you for supporting schools! Our public schools accept and welcome **all** children! Flathead County has nineteen (19) independent public elementary school districts and four (4) high school districts for a total enrollment of approximately **13,800 students**. Also available are a number of private elementary and high school districts and a significant home school population. Total enrollment for these non-public schools is approximately **1,677 students**. Parents have choices.

Time and change must co-exist. "We cannot turn back the clock." In this technology/information era, schools continually strive to meet ever-increasing demands. The basic education goal remains the same—preparing our youngsters for the future. The term "future", traditionally implied some enigma and some predictability. For this report, figures are taken from (1) last year's, year-end financial reports (2013-2014 *Trustees Financial Summary*), (2) the current year school district budgets (2014-2015), and (3) the current year enrollment data as of October 6, 2014.
