Quarantine Options (Please circle and initial beside the option you have chosen):

1. You may quarantine your animal at the Flathead County Animal Shelter at a cost of \$25.00/day with a \$30.00 impound fee. If your animal is unvaccinated and/or does not have a current Flathead County Dog License, you will also be charged a \$10.00 rabies vaccination fee and/or a \$45.00 licensing fee before being released from quarantine.
2. With permission and instruction of Animal Control or the Health Officer, you may quarantine your animal at your veterinarian office at your expense. If your animal is unvaccinated and/or does not have a current Flathead County Dog License, you will also be required to rabies vaccinate your animal prior to release from quarantine and obtain a \$45.00 licensing fee before being released from quarantine.
3. With permission and instruction of Animal Control or the Health Officer, you may quarantine your animal at home. If your animal is unvaccinated and/or does not have a current Flathead County Dog License, you will also be required to rabies vaccinate your animal prior to release from quarantine and obtain a \$45.00 licensing fee before being released from quarantine.
4. You may surrender your pet to Flathead County. With this option, your pet will be euthanized and the head sent to the Montana Veterinary Diagnostic Laboratory for rabies testing. The cost of this option is \$150.

Fees for using Flathead County Animal Shelter are to be paid at the time of drop off for quarantine or surrender.
