### Route for Statement of Intent

(DETITLING MANUFACTURED HOME)

#### PART ONE:

- Department of Motor Vehicle Request a <u>Statement of Intent</u> Form MV72(5/22).
   Complete the Statement of Intent in its entirety (both pages), including the signatures and notarized.
- 2) Flathead County Treasurer- This is in the same complex building. All taxes, interest, and penalties on the manufactured home must be paid in full. Request they issue a copy of the <u>Tax Paid Receipt</u>
  - a) This receipt **does not** need to be recorded with the statement of intent, hold on to it.
- 3) <u>Clerk and Recorder</u>- Submit the completed <u>Statement of Intent</u> to be recorded. They will issue ONE (1) certified copy. Recording fees will be due at that time.
- 4) <u>Department of Revenue-</u> Must provide documentation for review.
  - a) Certified copy of the Statement of Intent
  - b) Copy of the Tax Paid Receipt

If completed, The Department of Revenue will then issue a <u>Green Slip</u> that needs to be taken and submitted to the <u>Department of Motor Vehicle</u> with the other documentation.

- 5) Department of Motor Vehicle- Must provide documents to submit.
  - a) The recorded, certified copy of the Statement of Intent
  - b) The certificate of origin or certificate of title for the manufactured home.
  - c) The Green Slip from the Department of Revenue.
  - d) The Tax Paid Receipt
  - e) Estimated fee of \$10.30 will be due at this time.

<u>Department of Motor Vehicle</u> will submit the documents to Helena for processing. Helena will then, mail a statement verifying the de-titling process, along with the certified copy of the <u>Statement of Intent</u> (originally issued by the clerk and recorder, in step 3.

#### PART TWO:

<u>MOST IMPORTANT</u>, upon receipt of the above documentation in the mail, it MUST then be re-submitted to the <u>Clerk and Recorder</u>.

- Clerk and Recorder- RE-SUBMIT the same certified Statement of Intent to be recorded for a <u>SECOND time</u>. They will issue ONE (1) certified copy, showing the <u>SECOND</u> recording. Recording fees will be due at that time.
- 2. <u>Department of Revenue-</u> MUST submit the certified copy of the <u>Statement of Intent</u> showing <u>both</u> recordings. <u>The ownership records used for assessment and taxation purposes cannot be changed until we receive this documentation.</u> The process is then complete.
