#### **BALLOT ISSUES**

### EVERGREEN FIRE DISTRICT (VOTE IN ONE OVAL)

Shall the qualified voters of the Evergreen Rural Fire District authorize the Flathead County Commissioners to henceforth, authorize the mill levy of 77.67 mills, sufficient to raise approximately \$2,556,795 dollars, for the purpose of personnel, and vehicle and equipment replacement; of which 12.54 mills, approximately \$412,779, will be allocated to the capital improvement program account; such mills to be levied against all Evergreen Fire District taxable property?

The property tax impact of the levy vote on a home valued at \$100,000 would be \$104.86 equaling \$8.74 per month, or \$0.29 per day; a home valued at \$300,000 would be \$314.56 equaling \$26.21 per month, or \$0.86 per day; a home valued at \$600,000 would be \$629.13, equaling \$52.43 per month, or \$1.72 per day; and upon the average home value of \$444,700 would be \$466.29, equaling \$38.86 per month, or \$1.28 per day.

The 2019 ten-year voted levy would immediately expire and be replaced by this permanent levy.

The additional property taxes that would be imposed if the mill levy were to pass, compared to the current ten-year voted levy, upon a home valued at \$100,000 is \$53.93 equaling \$4.49 per month, or \$0.15 per day; upon a home valued at \$300,000 is \$161.80 equaling \$13.48 per month, or \$0.44 per day; upon a home valued at \$600,000 is \$323.60 equaling \$26.97 per month or \$0.89 per day; and upon the average home value of \$444,700 is \$239.84, equaling \$19.99 per month, or \$0.66 per day. This increase will not affect taxation by other governmental agencies and is only for Fire District purposes.
