Department Overview: The Flathead City-County Health Department is a public health agency providing certain statutorily-mandated services and other contracted services to people who reside in or visit Flathead County. As a division of the health department, the Flathead Community Health Center provides clinical services to the community, including acute, chronic and preventative medical care and education for people of all ages through the patient centered medical home clinical services; a 340B pharmacy program to assist in the purchase of medications for patients who cannot pay; urgent and non-urgent dental care; reproductive health services such as physical exams, contraceptive supplies, pregnancy testing, counseling, STD testing, treatment and follow up; and case management services to high risk Medicaid recipients.

Job Summary: Under the supervision of a designated program manager or supervisor where applicable, performs a variety of public health nursing services in clinics, homes, schools, and institutions.

Essential Functions (Major Duties or Responsibilities): *These duties are the essential functions and are not all-inclusive of all duties that the incumbent performs.*

- Identifies the physical, social, and emotional health needs of individuals, families, and communities through systematic assessment utilizing professional nursing skills, health histories, physical assessments, laboratory data and other tools and data;
- Makes visits to client's homes, day care center, foster homes, schools, and related care facilities; investigates for communicable diseases; conducts inspections for compliance with state regulations.
- Develops and implements nursing care plans by providing nursing care or appropriate referral to area agencies and practitioners; monitors client's; maintains documentation on clients; determines eligibility of clients for participation in programs.
- Promotes and maintains health of individuals, families, and the community through education, counseling, and appropriate preventive and rehabilitative measures; provides a variety of health related classes and talks to groups.
- Administers immunizations to infants, senior citizens, program participants, and the public.
- Adheres to established nursing procedures and agency Bloodborne Pathogen Exposure Control policies at all times.

- Provides answers to health-related questions and a variety of health information to the public upon request.
- Participates as the department representative on a professional or community association; assumes responsibility as resource for an assigned department function.
- Attends program related meetings and conferences, which may require overnight stays.
- As assigned, assists Community Health Services Director with administration and reporting for public health nursing contracts.
- Performs related work as assigned.

Physical Demands and Working Conditions:

Work is performed in an office environment and the community and requires typical range of motion and physical agility associated with the operation of equipment required to fulfill the duties of this position. The employee has occasional to frequent contact with body fluids and appropriate personal protective equipment is required.

Supervision Exercised: The primary function of this job is not in a supervisory capacity.

Knowledge, Skills, and Abilities:

- Knowledge of human development, public health nursing principles, and practices and standards of nursing.
- Skill in performance of all aspects of patient care and assessment including direct care, counseling, guidance, motivating patients for change and applying public health principles into practice.
- Ability to accept and utilize supervision and/or consultation.
- Ability to communicate effectively verbally and in writing.
- Ability to be sensitive to the needs, concerns, and rights of others.
- Ability to establish and maintain effective working relationships with peers, other agency personnel, and the public.
- Ability to assume responsibility for assigned tasks as directed.
- Ability and willingness to travel.

Education and Experience:

- Bachelor's degree in nursing from an accredited university school of nursing including academic and experiential preparation in public health nursing. The program must be accredited by the National League for Nursing. (May be waived for Associates Degree in Nursing and equivalent experience in position specific to job duties.)
- Possession of a current license to practice as a registered nurse in the State of Montana.
- Possession of a valid Montana driver's license, proof of insurability, and safe driving record.

Pay Classification: Registered Nurses with a Bachelor of Science Degree will be placed at Grade 9 in the Health Department matrix. Associate Degree Registered Nurses will be placed at Grade 8 in the Health Department matrix.
