Letters of interest are being accepted for a limited number of openings on Flathead County Boards and Committees

NEIGHBORHOOD LAND USE ADVISORY COMMITTEES

Ashley Lake Land Use Advisory Committee

There are three (3) openings currently available for service on this committee. Two (2) vacancies are for on-lake property owners. One (1) 4-year term would begin immediately and run through December 31, 2018. One (1) existing on-lake property owner vacancy would begin immediately and run through 12/31/2016. One (1) vacancy is for off-lake owners and would begin immediately and run through December 31, 2018.

Columbia Falls City-County Planning Board

There is currently one (1) county vacancy on this board. Applicants must reside within the planning jurisdictional area but outside the city limits of Columbia Falls. The two (2) year term would begin immediately and run through December 31, 2016.

Egan Slough Planning & Zoning Commission

There is currently one (1) opening on the Committee. The applicants, or their immediate family, must own property within the boundaries of the Zoning District. The existing vacancy would begin immediately and run through December 21, 2015.

Helena Flats Land Use Advisory Committee

There are currently five (5) openings on the Committee. The applicants must own real property in the Helena Flats Land Use Area as defined or live in the area of the Helena Flats District. One (1) term will begin immediately and run through December 31, 2018. Four (4) of the vacancies were not filled last year therefore; the remainder of two (2) of the 4-year terms would begin immediately and run through December 31, 2016, the remainder of one (1) term would begin immediately and run through December 31, 2017, the other one (1) remainder of the 4-year terms would begin immediately and run through December 31, 2017.

La Brant-Lindsey Lane Land Use Advisory Committee

There a currently one (1) vacancy on the Committee. Applicants for the existing vacancy must own less than 20 acres of property in the La Brant-Lindsey Lane Neighborhood Plan area or zoning district. The remainder of the term would begin immediately and run through December 31, 2016.

Little Bitterroot Lake Land Use Advisory Committee

There is currently one (1) vacancy not filled last year. Applicants must be a property owner from within the neighborhood who owns land that does not front or abut on Little Bitterroot Lake. The remainder of the term would begin immediately and run through December 31, 2016.

Middle Canyon Land Use Advisory Committee

There is currently one (1) opening on the Committee. The applicants must reside within the land use region of the jurisdiction. The remainder of the term would begin immediately and run through December 31, 2017.

Riverdale Land Use Advisory Committee

There are currently two (2) openings not filled last year on the Committee. The applicants must either reside and/or own land in the land use area of Riverdale. The applicants for one (1) opening must be representatives of the agricultural community who are actively engaged in the production of agricultural crops. The terms remainder of the four (4) year terms would begin immediately and run through December 31, 2017.

Rogers Lake Land Use Advisory Committee

There are currently two (2) openings not filled last year on the Committee. The applicants for one (1) opening must be a state lease holder. The remainder of the 4-year term would begin immediately and run through December 31, 2015. The applicants for one (1) vacancy must be an on-lake owner and the remainder of the four (4) year term would begin immediately and run through December 31, 2017.
