**Department Overview:** The Flathead County Solid Waste District provides environmentally sound and cost-effective refuse collection, disposal and recycling opportunities for Flathead County residents and businesses. Our facilities are a major part of the economic and environmental infrastructure of Flathead County. Long range planning and fiscal integrity ensures decades of capacity with minimal financial impacts to Flathead County citizens.

**Job Summary:** The Landfill Equipment Operator/Refuse Truck Driver performs a variety of tasks requiring skilled operation of heavy construction equipment and front-end loading refuse trucks to manage the landfill and container sites located throughout the county. An Incumbent in this position will work under the direct supervision of a foreman, must maintain a customer service oriented environment, and cooperate with other County departments and governmental entities.

**Essential Functions (Major Duties or Responsibilities):** *These duties are the essential functions and are not all-inclusive of all duties that the incumbent performs.*

- Perform a variety of tasks requiring skilled operation of heavy equipment and front-end loading refuse trucks in a safe and efficient manner while following grade tolerances.
- Load and unload refuse trucks effectively and efficiently.
- Obey traffic laws and follow established traffic and transportation procedures.
- Operate a communication system (e.g., radio).
- Discuss landfill and container site policies to customers in a courteous manner.
- Perform daily inspection and routine maintenance of assigned equipment.
- Operate and perform daily inspection of cardboard compactor.
- Perform manual tasks associated with the department work.

**Non-Essential Functions:**

- Perform other duties as assigned including but not limited to managing special projects, attending meetings and conferences, providing backup for other staff, etc.

**Physical Demands and Working Conditions:** *The demands and conditions described here are representative of those the employee must meet to perform the essential functions of the job.*

- Frequently required to stand, walk, bend, reach, sit, climb, push, pull and hear. Required to use hands and arms in driving a heavy vehicle and completing routine maintenance.
- Specific vision abilities required to include close, distance, color, and peripheral vision, depth perception and the ability to adjust focus.
- Frequently required to lift and/or move up to 50 pounds; occasionally 50 to 100 pounds.
- Constantly exposed to all weather conditions.
- Exposure to municipal solid waste, but rarely in direct contact.
- Required to report to work on time for scheduled shifts which may include weekends and most major holidays. The Solid Waste department is open for business 7 days a week and most major holidays.

**Supervision Exercised:** The primary function of this job is not in a supervisory capacity.

**Knowledge, Skills, and Abilities:**

This position requires knowledge of:

- basic mechanical operations of heavy equipment.
- all traffic laws and standard processes for the safe operation of a vehicle within a public roadway.
- the uses and purposes of hand tools.
- safe work practices including knowledge of safety principles involved in operating heavy equipment in a landfill environment.

This position requires the skill and ability to:

- perform routine maintenance.
- safely operate large vehicles and equipment in both basic traffic conditions as well as large scale public works projects in all weather conditions.
- read, write, and follow both verbal and written instructions.
- establish and maintain effective working relationships with supervisors, co-workers, and the public.
- demonstrate physical strength and agility sufficient to perform the work of the position.
- obtain 40 hour hazardous waste training certification.
- obtain First Aid and AED certification.
- obtain and maintain a Class A Commercial Driver's License.
- be medically certified for the position and pass pre-employment and ongoing drug screening.

**Education and Experience:**

Class A commercial driver's license with two years of heavy equipment operating experience and/or truck driving experience, or any combination of experience and training which indicates possession of the knowledge, skills, and abilities listed.
