

1. **Call Meeting to Order & Pledge of Allegiance:** 17:31
2. **General Public Comment:** Thank you for the pizza.
3. **Review/Approval of meeting minutes February 23rd, 2021:**
A motion to approve the minutes from February 23rd, 2021, Wilson (1st), Borges (2nd), no comments, all in favor, none opposed.
4. **Review/Approval of Purchase Orders:** No purchase orders were presented.
5. **Review/Approval of Reconciliation of Financial Statements and Bills Paid:** Wilson questioned when the ambulance was coming out of FUND#7254 line for apparatus. It was explained that reconciliation was done to end of month and just last week the flathead county issued check for the ambulance and it would show on this month, reports presented were up to the end of February.
